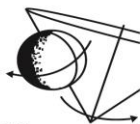

Many insurances require prior authorization for radiology exams such as MRI, CT, Ultrasound, Dexa, and X-Ray.
The referring office must obtain prior authorization from HMO insurances before the study is scheduled.

For IV contrast exams, please obtain authorization for **BOTH** the **without/with contrast CPT code** AND the **without contrast CPT code**: example 70553 MRI BRAIN WWO **and** 70551 MRI BRAIN WO.

We will attempt to obtain prior authorization on all PPO insurances.

Please provide our office with the following information for PPO insurance authorizations:

- Your Office Tax ID# / NPI / Clear copy of insurance card (**front and back**) **Primary and Secondary**
- Clear copy of RX with CPT/ICD-10 codes **AND** Clinical notes, including reports from related prior studies
